Sitar Rental Agreement

Congratulations on renting a sitar! I'm sure you'll find it to be a fascinating, challenging and life-enriching instrument. Please read and familiarize yourself with the terms and conditions in this agreement. If you have a problem or issue during the rental, I need to be informed immediately.

By renting a sitar from me, Joshua Feinberg, you (the renter) are agreeing to the terms which will be listed in this Sitar Rental Agreement. It is the renter's responsibility to read this document and become familiar with the terms and conditions which are outlined within it.

I, Josh Feinberg, am agreeing to the instrument being in the renter's possession only if he/she agrees to the terms in this agreement and pays the rental fee on time (outlined below). If the renter defaults on rental payments for more than 1 month without returning the sitar, I will contact the police and report the instrument stolen.

ID and Credit Card Required

In order to rent a sitar, you must provide me with a clear photo copy of a government issued photo ID (such as a driver's license or passport) and a credit card. In most cases, you can bring the cards to me and I will make a scan of them at my office. In the event that the credit card given ceases to work for any reason, the renter must supply a replacement card immediately.

Rental Costs and Payments

Sitar rentals for most sitars is \$65/month. Payment can be made in cash, check or credit card and are due on the first of the month. In most cases, I will charge the rent to the credit card you gave me at the time of rent. It will be put through on the 1st of each month. There is a 2 day grace period for late payments. If I have not received the payment after this grace period a \$20 late fee may be added to the outstanding amount. Late fees cannot be put towards the purchase of a sitar in the "rent to own" program. Prepaid fees for renting an instrument are non-refundable.

Discontinuing Rentals by You

Sitar will only be available to rent for students taking regular lessons. If the renter wishes to discontinue lessons with me, they must return the sitar as soon as they can so it can be made available to other students/renters. If the instrument is not returned within 30 days, I will contact the police and report the instrument stolen.

Discontinuing Rentals by Me

I may terminate the rental agreement at any time for any reason. If the renter has paid for time which is not used, I may or may not refund a prorated amount at my own discretion. Once I have canceled the rental of the instrument and asked for it to be returned, the renter has 30 days in which to return the instrument to me. If the instrument is not returned within 30 days, I will contact the police and report the instrument stolen.

Rent-To-Own Program

75% of rental fees for the first 4 months (up to \$200) may be put directly towards the purchase of an instrument. Each month, \$48.75 of the \$65 rental fee may be applied towards the purchase of an instrument. Up to 4 months and a student rents the instrument for 4 months, then the renter will have a \$195 credit towards the purchase of the instrument. Any rental fees paid after the first 4 months of rentals will not be added towards the purchase of an instrument. It is the renter's responsibility to keep track of the rent-to-own program schedule. In most cases, the rental instrument is not for sale. The rent-to-own program payments will be applied towards another instrument which must be purchased through me.

Damages, Theft, or Losses

The renter will take sole responsibility for any damages, theft, or losses which may occur to the instrument while they are renting it. It is the renter's responsibility to inspect and immediately disclose any damage to the instrument before he/she rents the sitar. Any damage found after the agreement is signed and the sitar rental is paid for, will be attributed to the renter. Damages will be assessed and appraised by me, Josh Feinberg. The damage will be valued at either how much it will cost to repair or replace the instrument (labor is \$40/hour plus the cost of replacement parts). Damage fees may be paid in cash, bank check, money order, or charged to the credit card which you have provided me when you began renting the instrument. Damage fees may also be assessed if there is damage to the case.

The sitar is only allowed to be possessed by the person renting it, and may not be used or stored by anyone else for any period of time.

Storage and Care of the Instrument

The renter agrees to take proper care of the instrument while he/she is renting the instrument. It can be useful to think of the sitar like a baby—if you wouldn't do some-

thing to a baby, chances are you shouldn't do it to a sitar. Proper care includes but is not limited to:

- Never leave the instrument in the car unattended for any amount of time.
- Never leave the instrument in direct sunlight (this can damage the wood and finish).
- Never allow the instrument be exposed to excessively hot or cold weather.
- Wipe the instrument down with a clean, dry rag after playing.
- Keep the instrument in the case when not using it,
- Wash your hands before playing the instrument.
- Do not leave the sitar any elevated surface including but not limited to tables, beds, chairs, etc.
- Keep the instrument in a clean place and not expose it to dirty environments.
- The rental sitar is not allowed to be taken on an airplane.
- Do not take the rental sitar out of either Oregon or Washington state.
- Do not let moisture or liquid get near or contact the instrument.
